IMPORTANT:

- Subjects approved for Provisional admission may be **re-allotted** depending upon the **Board Examination Result**.
- Total percentage will be calculated on the basis of marks obtained in **the first five subjects** of the Mark sheet.
- Parents have to submit a written application for **the change of optional subjects (if any)** which can only be granted based on the Board Examination Result.
- The school may or may not allot certain subjects to students depending upon the capability of the student to study a particular subject based on their performance in the Board Examination and/or the Number of students already enrolled per subject that should not exceed the student-teacher ratio specified by CBSE.
- RECORD OF DISCIPLINE WILL BE A CONSIDERING FACTOR FOR THE SCHOOL TO ENROLL THE STUDENT IN CLASS XI.**
- The decision on the admission criteria fixed by the school is final and is to be strictly adhered to.
